However, our customers will be informed in advance if an event involves a significant overshooting of the estimated cost in regards of the services.

REPAIR DELAYS

Any date given to our customers as to the execution of our services is deemed to be approximate. In no case, will Gravel Agency Inc. be responsible for any direct or indirect damage sustained by the customer as a result of a delay in relation to such a date.

LIMITATION OF RESPONSIBILITY

Gravel Agency cannot be held liable to the customer or to any third party:

- For any damage, direct or indirect, if, following repairs done by Gravel Agency Inc., the firearm is not used or stored in a safe manner and in accordance to the manufacturers standards, or is modified by the customer or any other person.
- For any damage, direct or indirect, related to the functions or parts of a firearm not checked by Gravel Agency Inc., while the customer asks for a specific repair without a general inspection of the firearm.

- For any damages, direct or indirect, caused while the customer requests a modification of the firearm in order to render it less safe, or while a customer refuses a repair that is necessary in order to ensure that the firearm is fully safe, in which case, Gravel Agency Inc. reserve the right to require the customer sign a special limitation of liability with acceptance of the risks involved.

APPLICATIONS AND INSTRUCTIONS

Gravel Agency Inc. reserves the right to accept or refuse, in whole or in part, any required service request or instruction given by the customer.

DETAINING OF THE FIREARM

In case of payment default by the customer, or for refusing to carry out necessary repairs to a firearm constituting a serious danger to its users, Gravel Agency Inc. reserves the right to keep any firearm in its possession until the customer remedy the situation within the time limit.

To the extent where the customer has not remedied the situation within this delay, Gravel Agency Inc. is authorized to proceed with the sale of the firearm in its possession or to dispose of it to the public authorities.

RESPECT OF LEGISLATION

All parties agree and accept to act in accordance to all laws, regulations and policies applicable to fire arms in Canada.

CHOICE OF JURIDICTION

All parties agree, for any claim and for any reason whatsoever arising from or in connection with this agreement, to choose the judicial district of Québec (Province of Quebec, Canada) as the appropriate place to hear such claims to the exclusion of any other court which may have jurisdiction under the provisions of the law.
